This Memorandum of Understanding (MOU) has been agreed to encourage contact and cooperation of mutual interests between the Parties.

1. The Parties will jointly develop academic cooperation to attain the goals of the following forms of activities:
 - a) Exchanging lecturers and students (including but not limited to exchange, internship and attachment);
 - b) Conducting scientific and academic activities;
 - c) Jointly conducting research, projects, seminars, training, and workshop;
 - d) Jointly conducting and involving in University Social Responsibility (USR) activities;
 - e) Publishing of academic papers in international journals, and;
 - f) Any other activities that the Parties deem mutually beneficial.
2. For the most effective results, representatives or authorized persons of both universities are signatories in the agreement of mutually acceptable academic cooperation.
3. This MOU will be in effect from the date of signature for a **period of five years**. It shall be extended automatically for an additional period of five years at each expiration date.
4. This MOU may be terminated by one of the universities, upon prior notice to the other in writing at least six months before the termination date.
5. The Parties do further hereby agree that this MOU is not intended to create any legal obligations and shall not be legally binding on the Parties hereto. In the course of implementation of the terms of this MOU, the Parties will execute a formal Collaboration Agreement or any other such written agreements in respect of any developments and/or expansion to the scope of the collaboration arising from this MOU.






